Dürr AG is a German holdings company which deals in mechanical products, engineering solutions and services required at various plants. The company caters to automobile manufacturers, pharmaceutical industries, aircraft industries, chemical industries etc. It is headquartered at Stuttgart, Germany. Dürr was founded by Paul Dürr as a metal shop for roof flashing in 1895, the company gradually evolved into a larger entity dealing with mechanical engineering. The company has approximately 120 units across 33 countries and operates through brands like Dürr, Schenck and HOMAG etc. It has a strong presence in North America, Western Europe and emerging markets like Asia. The group operates through five segments namely, Paint and Final Assembly Systems (PFS), Application Technology (APT), Clean Technology Systems (CTS), Measuring and Process Systems (MPS) and Woodworking Machinery and Systems (WMS). All segments are handled by Dürr AG which looks after central tasks like financing, controlling and accounting etc. As of 2021, the company has a total of 16,500 employees.

The company's Unique Selling Proposition or its USP is its technological expertise in automation and digitalization. It helps the firm's equipment, plants and services to attain maximum efficiency in production regardless of the industry. This has allowed the group to attain a leading position globally in its area of operation.
