Sectra AB is a Swedish firm that specialises in medical technology and secure communication solutions. It is headquartered in Linköping, Sweden. Sectra was established in 1978 by a group of Linköping University researchers. RAKEL, a communication system used by Swedish organisations and institutions that provide critical public services such as emergency services and public utility providers like power companies, is one of the company's most notable products. The company has two business divisions: Secure Communication Systems and Medical Systems. The Secure Communication Systems business area, which is managed by the Company's subsidiary Sectra Communications AB, provides security solutions to customers who handle sensitive information, such as government agencies, defence departments, and key societal functions across Europe. The Medical Systems business sector, which operates through the company Sectra Imtec AB, provides public and private healthcare providers with information technology (IT) solutions, software licences, service and upgrade agreements, online services, advisory services, and training courses. In May 2021, Sectra's contract with the Dutch ministries was renewed. The contract permits the Dutch ministries to continue to purchase Sectra's secure communication as a service.

Sectra's Unique Selling Point or USP lies in helping address the world's demands for more efficient healthcare and secure communication by providing products and services in medical IT and secure communications. Sectra's vision statement reads, "Driven by knowledge and passion, our vision is to contribute to a healthier and safer society. Sectra successfully develops and sells cutting-edge solutions in the expanding niche segments of medical IT and cybersecurity—a combination that makes us unique".
