Indra Sistemas S. A. is a Spanish company that specializes in information technology and defense systems. Indra is a member of the IBEX 35 index and is listed on the Bolsa de Madrid. The company was established in 1993 with its headquarters in Alcobendas, Madrid, Spain. Indra is made up of three sectors: information technology, simulation and automated test equipment, and defence electronic equipment. Indra's services include consulting, project creation, systems and application integration, and IT system and business process outsourcing. This package is divided into two parts: solutions and services. Indra claims to specialize in systems and solutions (including outsourcing and application maintenance) as well as business processes in which technology plays a strategic and differentiating role (BPO). Indra's core business areas include Air traffic control systems – where it appears to be one of the world's biggest suppliers; Indra claims that its systems handle a third of the world's air traffic, Rapid transit ticketing systems built in Madrid, Barcelona, Paris, Lisbon, Shanghai, Athens, Buenos Aires, Mumbai, and Santiago de Chile, Services in the financial sector, Electoral technology and processes in the energy sector, Simulators for planes, Information systems for defence health care. On April 19th, 2021 Indra announced that it will lead the Spanish RDI Mobility 2030 project, which aims to make modern smart, automated, and sustainable mobility a reality by overcoming current technical limitations for mass deployment of electric, connected, and autonomous vehicles on the roads, and promoting their incorporation into the new mobility as a service paradigm.

Indra Sistemas Inc.'s Unique Selling Point or USP lies in it being a leading global technology and advisory firm that serves as a technological partner for its customers' core business operations around the world and a global pioneer in proprietary technologies for particular segments of the transportation and defence industries.
