Mitsubishi UFJ Financial Group, Inc. is a Japanese financial service and bank holding firm headquartered in Chiyoda, Tokyo. On 1st October, 2005, Mitsubishi Tokyo Financial Group (MTFG) and UFJ Holdings merged to establish the corporation. On January 1, 2006, the group's two primary banking operations, Bank of Tokyo-Mitsubishi and UFJ Bank, combined to form MUFG Bank. MUFG is in charge of the Group's subsidiaries and the Group's company as a whole, as well as all essential ancillary businesses. MUFG has a global network of approximately 2,700 locations spanning the Americas, Europe, the Middle East and Africa, Asia, and Oceania. Commercial banking, trust banking, securities, credit cards, consumer financing, asset management, and leasing are among the services provided by the Group, which has over 180,000 people. In addition to treasury operations, the company provides sales and trading (S&T) services to its customers in the areas of interest rates, bonds, currency, and equities. The University of Tokyo and MUFG agreed to collaborate, in June 2021, in order to achieve carbon neutrality.

Mitsubishi UFJ Financial Group's unique selling point or USP lies in its being the leading global financial services company and one of Japan's largest banks.
