About the Company : Kyivstar is a Ukrainian telecommunications firm that offers communication and data transfer services using a variety of fixed and mobile technologies, including 3G and 4G. (LTE). The Company was established and registered in Ukraine in 1994 and has been providing mobile communications services since 1997 and is headquartered in Kyiv, Ukraine. Kyivstar is a subsidiary of VEON, one of the world's largest integrated telecommunications companies, headquartered in the Netherlands and listed on the NASDAQ and Euronext stock exchanges. The "Kyivstar" mobile network serves all of Ukraine's cities and towns, as well as over 28 thousand rural communities, all major national and regional highways, and the bulk of the country's sea and river coasts. The company now serves 85 per cent of the country's population with 4G coverage, with a target of reaching 90 per cent by 2021. In May 2021, the company announced that it will open TV services to subscribers of all operators. Kyivstar's USP is that it is Ukraine's largest mobile operator as well as one of the country's leading internet providers of broadband access ("Home Internet" service). The mission statement of Kyivstar reads, "to open new opportunities for Ukraine and change people's lives for the better"
