About the Company : On the 10th of November, 1987, the firm was incorporated under the laws of the state of Delaware. Geographic assets include known and probable copper, gold, and molybdenum reserves, as well as a traded copper producer. It functions through the following segments: Copper Mines in North America; Copper Mines in South America; Copper Mines in Indonesia; Molybdenum Mines; Rod and Refining; Copper Smelting and Refining in the Atlantic; and Corporate, Other, and Eliminations. The Grasberg minerals district in Indonesia, as well as substantial mining operations in the Americas, such as the large-scale Morenci minerals district in North America and the Cerro Verde operation in South America, are among the firm's holdings. As of February 2021, the company ranks 215 on Fortune 500 list.

Freeport-McMoRan's USP or unique selling point lies in it being the world's largest producer of molybdenum and one of the world's largest producers of copper.
