The business was formed by Trevor Milton in Salt Lake City, Utah, in 2014. Its product line comprises class 8 commercial trucks, off-highway vehicles, and watercraft that are all battery-electric or hydrogen-electric. Nikola One, Nikola Two, Nikola Tre, and Nikola Badger are just a few of the company's offerings. Nikola NZT, Nikola Reckless, and Nikola water adventure vehicles are among the company's Powersports vehicles (WAV). Nikola Corporation announced a partnership with PGT Trucking, Inc. Following the successful completion of a Nikola Tre FCEV demonstration programme, the parties will sign a Letter of Intent (LOI) to lease 100 Nikola Tre heavy-duty fuel cell electric vehicles (FCEVs) on terms to be agreed upon.
