In 1986 Ting Tsung Chao established the company and its headquarters are situated in Houston, Texas.Olefins and Vinyls are two of the company's segments. At the Lake Charles site, the Olefins section produces ethylene, polyethylene, styrene, and related coproducts, while the Longview unit produces polyethylene. Vinyls manufacture and sell pipe, fittings, profiles, foundations, building products, fence and deck components, window and door components, film, and sheet products, among other building materials. The ethylene produced by the company is used in the polyethylene, styrene, and VCM processes. In addition, the company sells propylene, crude butadiene, pyrolysis gasoline, and hydrogen, as well as ethylene and ethylene co-products. As of 2021, the company leverages the talent of 9022 employees.

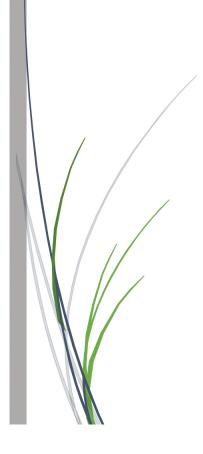
