Fuchs Petrolub SE is a global lubricant and speciality product company headquartered in Mannheim, Baden-Württemberg, Germany. The company's portfolio of products consists of automotive lubricants, industrial lubricants, metal-working fluids, and lubricants for special applications. Engine and gear oils, metalworking fluids, shock-absorbent fluids, corrosion inhibitors, hydraulic oil, and greases are among the company's offerings. FUCHS PETROLUB is a global company with about 60 subsidiaries and about 35 production facilities. It has Fuchs Lubricants in the United States and FUCHS LUBRITECH in the United Kingdom, which produces speciality lubricants for the food and beverage industries. It also provides process and technical support. The company has a diversified product line of over 10,000 items and serves customers in over 50 countries. The company stated in November 2021 that it would provide EUR 50,000 to 14 social projects in Mannheim. As of early 2022, FUCHS has approximately 6,000 employees across all its offices.

Fuchs Petrolub's USP is that it is the largest source of independent lubricant makers in the world. The mission statement of the company reads, "We deliver leading technology and first-class service to our customers. Identify and create FUCHS Value Added. Provide space for innovation to explore new paths. Act with an entrepreneurial spirit".
