About the Company : The Voith Group manufactures pulp and paper mills, as well as technical equipment for hydropower plants and driving and braking systems. The family-owned business was formed in 1867 and has its headquarters in Heidenheim a der Brenz. Under the umbrella of this holding corporation, four distinct sections are organized: Voith Sulzer Paper Technology, which makes machines and systems for the production of mechanical pulp, paper, and paper finishing; Voith Turbo Power Transmission, which makes automatic transmissions for buses, coaches, and trucks, rail vehicle drive systems, and hydrodynamic couplings and drive systems for industrial use; Voith Fluid Machinery, which manufactures turbines, storage pumps, and control technology for hydropower plants and marine technology; and Voith Appl. In addition, J.M. Voith is involved in research and development in each of its fields. Voith is a global player with production facilities in Europe, North and South America, and Asia, as well as sales offices in over 100 countries across all continents. Exports account for over 80% of J.M. Voith's revenues. Voith has decreased CO2 emissions at all of its locations to "net zero" as of the beginning of 2022. As a result, beginning in January, the Group's operations will be carbon-neutral.

The Voith Group's USP is that it is a global technology company that produces a significant portion of the world's paper on Voith paper machines and sets standards in the energy, oil and gas, paper, raw materials, and transportation and automotive industries. The mission statement of the company reads, "To be a world-class manufacturing company. To add value to customers, provide career opportunity to our employees, support the community at large and protect the environment for the future".

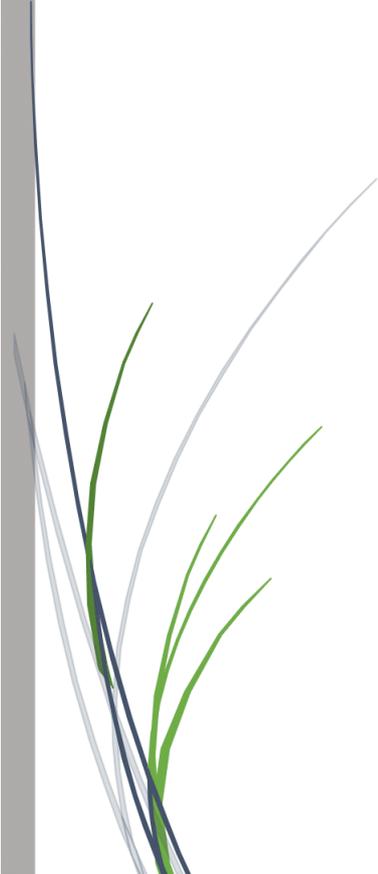
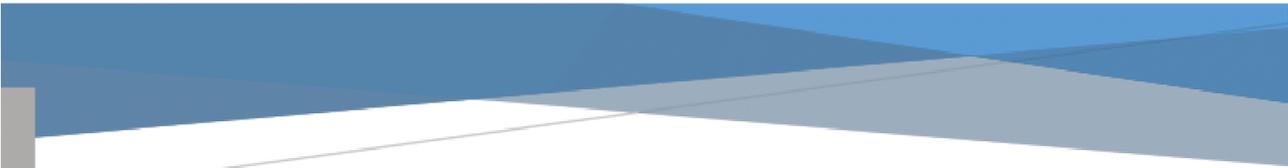
