About the Company: Euronext N.V. is a pan-European stock exchange that trades regulated stocks, exchange-traded funds (ETFs), warrants and certificates, bonds, derivatives, commodities, foreign exchange, and indexes. The registered office and corporate headquarters of Euronext are respectively in Amsterdam and Paris. Its beginnings can be traced back to the establishment of the Amsterdam Stock Exchange by the Dutch East India Company in 1602. The stock exchanges of Amsterdam, Paris, and Brussels merged to become Euronext in the year 2000. The national listing venues of Euronext administers Euronext Growth and Euronext Access, multilateral trading facilities (MTFs) that give access to listing for small and medium-sized businesses in addition to its main regulated market. The business also operates Euronext Clearing, a multiasset clearinghouse, and Euronext Securities, a central securities depository (CSD), which provides custody and settlement services. It controls 66 per cent of Nord Pool, a European power market that facilitates electricity trading. Day-ahead and intraday trading, clearing and settlement, data and compliance, and consultation services are all available through Nord Pool. With about 2000 listed issuers and a market value of more than 6.9 trillion at the end of Dec

Euronext's USP is that it is the world's largest hub for debt and fund listings, as well as a technology and managed services provider for third parties. The mission statement of Euronext reads, "Connecting European economies to global capital markets, to accelerate innovation and sustainable growth".
