**About the Company :** Adani Enterprises Limited is an international trading house that operates from offices in India as well as other countries. It was founded in 1988 by Gautam Adani with its headquarter being located at Ahmedabad, Gujarat. The Company is involved in coal mining, cargo handling and power generation. Adani also trades in a large number of products including textiles, energy, metals and agricultural products. Adani Enterprises Limited (AEL) is the flagship company of the Adani Group, one of India's largest business organizations. As of 2021, Adani Group hosted the TiE Sustainability Summit (TSS 2021) with the aim of creating awareness about opportunities and enabling entrepreneurship in the sustainability ecosystem. Over the years, Adani Enterprises has focused on building stellar infrastructural assets contributing to nation-building. In early 2022, Adani Group announced \$70 billion of investments in the renewable energy value chain. The Adani Group under the leadership of Gautam Adani has been the recipient of many awards and honors for its corporate performance. Some of them being: It received the Dun & Bradstreet – Rolta Corporate Award 2008” for outstanding performance in Trading after the performance evaluation of over 500 companies. Having successfully built unicorns like Adani Transmission, Adani Power, Adani Ports & SEZ, Adani Green Energy and Adani Total Gas, the company has contributed significantly to make the country self-reliant.

Adani Group's USP or unique selling point lies in its largest private thermal power producer in India. They have a power generation capacity of 12,450 MW comprising thermal power plants in Gujarat, Maharashtra, Karnataka, Rajasthan, and Chhattisgarh and a 40 MW solar power project in Gujarat. Adani Group's vision statement reads, “To be a world class leader in businesses that enrich lives and contribute to nations in building infrastructure through sustainable value creation.”

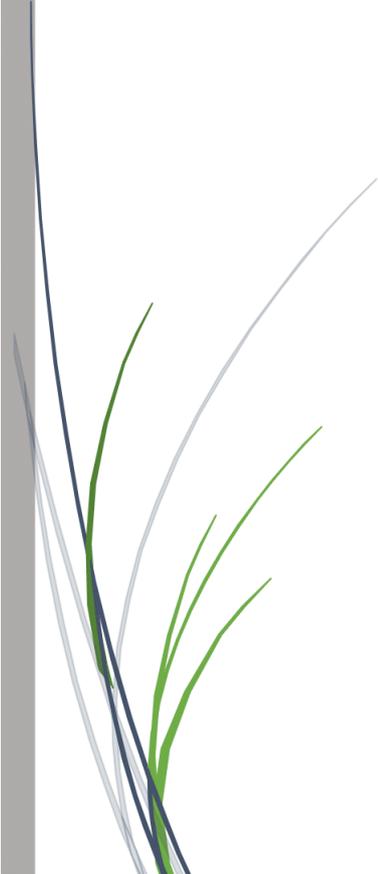
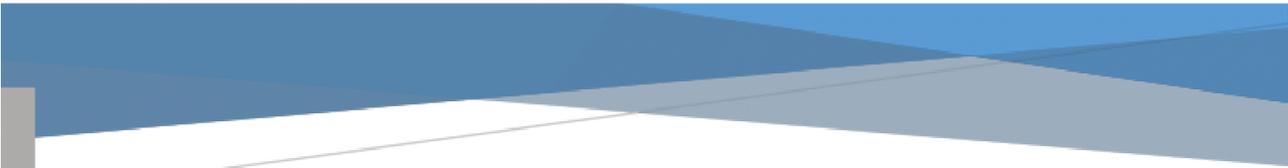
