About the Company : Headquartered in Chicago, Illinois, U.S., CommonSpirit Health is a nonprofit healthcare system which was created by combining Catholic Health Initiatives and Dignity Health in early 2019. By combining the resources of both the entities, the organization aims to build healthy communities for the poor and vulnerable. The company focuses on 3 main segments: Advancing Health Equity, Improving Population Health, and Innovation in Healthcare. CommonSpirit provides its services in 21 states in the U.S. and has around 1000 care centers and 139 hospitals. The services are provided with the help of around 150,000 health care workers. In February 2022, CommonSpirit allied with Morehouse School of Medicine to introduce 'More in Common Alliance' to increase cultural capabilities and expand minority representation in clinical care.

CommonSpirit Health is committed to meet patients need anywhere and anytime. So, to fulfill this, CommonSpirit introduced virtual visits where it could provide its services to patience and also add benefits to the environment. Since March 2020, CommonSpirit Health Physician Enterprise doctors and Advanced Practice Providers have conducted over 2 million telehealth visits with patients. This has led to the reduction of over 20,000 metric tons of greenhouse gas emissions.

CommonSpirit Health's unique selling proposition or USP lies in being one of the largest Catholic health system and the second largest non-profit hospital chain in the United States. CommonSpirit's mission Statement reads, "As CommonSpirit Health, we make the healing presence of God known in our world by improving the health of the people we serve, especially those who are vulnerable, while we advance social justice for all", while its vision is, "A healthier future for all – inspired by faith, driven by innovation, and powered by our humanity."
