About the Company: ICL Group Ltd. (previously Israel Chemicals Ltd) is a multinational chemical company headquartered in Tel Aviv-Yafo, Israel, develops, manufactures, and sells fertilisers, metals, and other speciality chemicals. The company was formed in the mid-1970s when two key areas of Israeli mineral production, phosphates from the Negev Desert and potash and other minerals from the fertile Dead Sea basin, were combined. Agriculture, food, and engineered materials are the three main markets that ICL serves. It's a company that makes specialist fertilisers and phosphates, as well as flame retardants and water treatment products. It also generates more than 9% of the primary magnesium consumed in Western markets. More than 60% of the company's output comes from concessions in the Dead Sea (potash, bromine, salt, magnesium, and magnesium chloride) and the Negev Desert (potash, bromine, salt, magnesium, and magnesium chloride) (phosphates and limestone). The business also maintains manufacturing facilities in the United States, Chile, France, the Netherlands, Germany, China, and abroad, as well as operating potash mining licences in England through subsidiary Cleveland Potash and in Spain through subsidiary Iberpotash.In January 2022, ICL announced that it has been awarded the prestigious gold medal rating by EcoVadis for the first time, putting it in the top 5% of 75,000 evaluated suppliers.

ICL's USP lies in its being the largest manufacturer of potash, bromine, and other mineral and chemical compounds around the world. The mission statement of ICL Group Ltd. reads, "We are committed to making an impact in the worlds of food, agriculture, and industrial products, and advancing humanity for a sustainable future".
