About the Company:

Sappi Limited is a South African corporation headquartered in Johannesburg. It was founded in 1936 as South African Pulp and Paper Industries Limited. Sappi's operations are divided into three divisions: Sappi Fine Paper, Sappi Forest Products, and Sappi Trading. Sappi Fine Paper North America, Sappi Fine Paper Europe, and Sappi Fine Paper South Africa are the three geographic business segments that run the company. North America, Europe, Southern Africa, and Asia are all home to Sappi Fine Paper's manufacturing and marketing facilities. The company's major areas of specialisation are graphic/printing papers, packaging and speciality papers, dissolving wood pulp (DWP), as well as goods in adjacent disciplines such as nanocellulose and lignosulfonate. The business has manufacturing operations in nine countries across four continents, with clients in more than 100 nations. In October 2021, Sappi Europe announced that it has decided to implement a broad energy surcharge across all goods because it can no longer bear the full impact of the enormous spike in energy prices.

Sappi's USP lies in its being a global leader in sustainable woodfibre products and solutions in the areas of dissolving pulp, printing papers, packaging and speciality papers, casting and release papers, biomaterials, and bio-energy. The mission statement of Sappi reads, "Through the power of One Sappi — committed to collaborating and partnering with stakeholders — we aim to be a trusted and sustainable organisation with an exciting future in woodfibre and products in adjacent fields".
