Private equity, venture capital, credit, public equity, impact investing, life sciences, and real estate are among the firm's specialities. In the United States, EMEA, and Asia, the private equity and venture capital investor acquires and owns stakes in firms in the business services, retail and consumer products, communications, healthcare, hospitality, financial services, industrials, and technology sectors. Aveanna Healthcare, Auto Distribution, Blue Nile, Camp Australia, Central Square Technologies, and Kestra Medical Technologies are among the companies in Bain's private equity portfolio. In December 2021, Bain Capital Credit, LP and affiliates of Fortress Investment Group LLC announced the acquisition of Project Frontier.
