Spanish international financial services provider CaixaBank, S.A., formerly known as Criteria CaixaCorp is headquartered in Valencia with operational offices in Madrid and Barcelona, Spain. Founded in 2007 as Criteria CaixaCorp, the corporation serves as a publicly-traded vehicle for La Caixa's ownership shares in and investments in companies that offer industrial and financial services. The company offers ownership in foreign banks as well as banking services like insurance, pension plans, and investment funds. It operates through the following divisions: BPI, Equity Investments, and Banking & Insurance. The core business of the Banking & Insurance segment consists of all banking activities, including retail banking, corporate banking, cash and markets, and insurance activities. These activities are primarily conducted in Spain through the branch network and other supplementary channels. Additionally, it provides general insurance products, pension plans, and life insurance. The Equity Investment segment of the firm engages in the equity investment business. The BPI segment comprises all businesses under the BPI group. CaixaBank was recognised as the "Best Private Bank in Europe for Big Data Analytics and Artificial Intelligence" as well as "Digital Marketing and Communication" by PWM (FT Group) in June 2022.

CaixaBank's USP is that it is the third-largest lender in Spain in terms of market value, with 5,397 locations to serve its 15.8 million clients and the most extensive branch network in the country. The mission statement of the company reads, "We contribute to the progress of society: Effectively and prudently channelling savings and financing, and guaranteeing an efficient and secure payment system".
