Jim Flavin established the corporation in 1976 under the name Development Capital Corporation Limited. The company's initial focus was on providing venture capital to start-ups, but in the middle of the 1980s, it changed course and began operating as an industrial holding company. The business provides goods and services for everyday use in about 20 different nations. DCC LPG, DCC Retail & Oil, DCC Healthcare, and DCC Technology make up the company's four business segments. With operations in Europe, Asia, and the US, DCC LPG is in the liquefied petroleum gas (LPG) sales and marketing business. It also operates a natural gas and electricity retailing operation in Europe. In Europe, DCC Retail & Oil sells, markets, and retails transportation and industrial fuels, heating oils, and related goods and services. With a focus on the healthcare industry, the DCC Healthcare sector offers goods and services to businesses that own health and beauty brands as well as to healthcare providers. DCC Technology is a supply chain and route-to-market partner for major international technology brands. Flogas Britain, a leading provider of off-grid energy solutions and a subsidiary of DCC plc, has acquired Protech Group in June 2022. This acquisition significantly expands the company's customer base and strengthens its portfolio of energy solutions.

The unique selling proposition of DCC plc is that it is a top-tier multinational sales, marketing, and support services business with a distinct focus on performance and growth. The mission statement of DCC reads, "to enable people and businesses to grow and progress".
