Founded in 1947, Bupa is an international health insurance and healthcare group. BUPA originally stands for British United Provident Association. The group has its origins and global headquarters in the United Kingdom. The main countries of operation of the group are: Australia, Spain, UK, Chile, Poland, New Zealand, Hong Kong SAR, Turkey, Brazil, Ireland, Mexico and USA. Along with having a presence across Latin America, the Middle East and Asia, Bupa also includes joint ventures in Saudi Arabia and India. The firm is a private company limited by guarantee and has no shareholders. It therefore reinvests any profits (after tax) in the business. Bupa was established at a time when seventeen British provident associations joined hands to provide healthcare for the general public. Earlier Bupa offered services like private medical insurance and policies to individuals, companies and others organisations. Later, it expanded to offer the same to privately run hospitals, dental centres and outpatient clinics, along with providing other healthcare services like health assessments, GP services, digital health and aged care. 72% of its revenue is represented by health insurance. In 2019, Bupa was ranked as the 5th best employer by LinkedIn, in the UK. In 2020 Forbes World's Best Employers List, Bupa was ranked 83rd out of 750 global companies. As of early 2023, Bupa Finance employed over 84,000 people.

Bupa's Unique Selling Proposition or USP lies in it being a private company having 31 million customers worldwide. The company nurtures an ambition to be "the world's most customer-centric healthcare company."
