JD.com owns the largest drone delivery system, infrastructure, and capability in the world thanks to investments in high-tech and AI delivery using drones, autonomous technology, and robots. JD Logistics has won two national awards for its contribution to the fight against COVID-19 recently. In June 2022, JD.com, Inc. announced that it had extended its three-year strategic cooperation agreement with Tencent. Tencent will continue to provide the Company with prominent Level I and Level II access points on its Weixin platform.
