Trimble provides services for industries in agriculture, construction, geospatial technology, transportation, governmental projects etc. The company operates in approximately 150 countries, and has offices in nearly 40 of them. It hopes to change the manner in which the world functions today, by offering such products and services that would help connect the dynamic physical and digital worlds easily. The company has a total of 11,402 full-time and part-time employees. Trimble's business revolves around 4 major segments namely - Building and Infrastructure, Geospatial, Resource and utilities and Transportation. Trimble announced in April 2022 that it had reached a final agreement to sell Precisional LLC, a subsidiary of The Jordan Company, its Time and Frequency, LOADRITE, Spectra Precision Tools, and SECO accessories businesses ("TJC"). The sale is consistent with Trimble's goal of concentrating on its strategic product roadmap and long-term growth areas.
