Coinbase Global, Inc., is a cryptocurrency trading platform based in the United States. With no physical headquarters, Coinbase is a remote-first firm. The company was established in 2012 by Brian Armstrong and Fred Ehrsam. It is a financial technology firm that specialises in end-to-end financial infrastructure and software. Its main goal is to create a crypto economy, which is a transparent financial system powered by crypto and based on crypto assets, which are digital assets created using blockchain technology. Its platform enables 43 million retail consumers from over 100 countries, as well as 7,000 institutions and 115,000 ecosystem partners, to participate in the crypto-economy. The company provides a primary bank account for retail consumers to invest in, store, spend, earn, and use crypto assets. It offers a one-stop shop for hedge funds, money managers, and businesses to access crypto markets through improved trading and custody technology. The Corporation provides a platform with technology and services that enable developers, merchants, and asset issuers to create applications that use crypto protocols, participate in crypto networks, and securely take cryptocurrency as payment. Coinbase in August 2022 announced a partnership with Blackrock which will enable Blackrock's Aladdin institutional clients with access to digital currencies.

Coinbase Global, Inc's USP lies in its being the largest cryptocurrency exchange in the United States by trading volume. The mission statement of the company reads, "To increase economic freedom in the world".
