Dana Inc. offers power-conveyance and energy-management solutions for machinery and vehicles. The business, which was established in 1904 and is headquartered in Maumee, Ohio, has close to 36,000 employees worldwide. The business provides driveshafts, axles, transmissions, and electrodynamic, thermal, sealing, and digital equipment for conventional, hybrid, and electric cars. Markets for light vehicles, commercial vehicles, and off-highway equipment are targeted by the company's goods and services. Automobiles, industries, and financial holdings make up Dana's three main business sectors. Four regional organisations in North America, South America, Europe, and the Asia Pacific are in charge of the company's global operations under its decentralised management structure. Dana evolved concurrently with the automobile industry, and by adapting to changes there, it has remained a pioneer in its sector. In April, 2022, Dana revealed that five cutting-edge electrification solutions it has developed have earned it a top ranking in the Automotive News PACE and PACEpilot Award programmes.

Dana Inc.'s USP lies in its being a world leader in drivetrain and electric propulsion systems. The mission statement of the company reads, "Driving stakeholder value by powering vehicles and machines around the world; shaping sustainable progress through invention and execution; and making the amazing happen wherever people live, work, and play".
