Volotea is a low-cost Spanish airline based in Castrillón, Asturias, Spain, with bases in Spain, Italy, France, and Greece. Volotea was founded by Alaeo S.L., a Barcelona-based firm founded by former Vueling founders Carlos Muoz and Lázaro Ros. It began operations from Venice Marco Polo Airport on April 5, 2012, and a decade later, it has carried over 40 million passengers around Europe owing to an exceptional team and a concept built on providing a pleasant travel experience at reasonable pricing. Every year, it increases the number of aircraft in its fleet, the number of routes it service, and the number of seats it offers, propelling it to become one of Europe's fastest growing independent airlines. Volotea services over 100 cities in 16 countries, with new additions in 2022 including Denmark, Italy, and Algeria. The airline will have a fleet of approximately 41 planes in 2022, up from 36 in the summer of 2019. Volotea became a full Airbus carrier in 2021 after replacing a portion of its fleet with European aircraft. Volotea was named "Europe's Leading Low-Cost Airline" in 2021 and 2022 at the World Travel Honors, the industry's most prestigious awards that recognise achievement in the transportation and tourism industries worldwide.

The USP of Volotea lies in it being the leading European low-cost airline. The mission of the airline is to connect people all around Europe, providing competitive prices.
