In 2010, the Mitsui Sumitomo Insurance and Aioi Nisaay Dowa Insurance were incorporated into one strong insurance holdings company with an aim to provide world class financial services with listings on the Nikkei 225. It was founded in 2008 as a holding company following in the lines of Mitsui Sumimoto Insurance Company Limited, Sumimoto Kirameki Life Insurance Company Limited, Mitsui Sumimoto MetLife Insurance Company Limited, and Mitsui Direct General Insurance Company Limited. As of early 2023, MS&AD has more than 39,000 employees. The services provided by the MS&AD are the handling of any companies with non-life and life insurance dealings and also any companies that are licensed to do so and any other business attached with the previous body. Their stock is listed on the Tokyo and Nagoya Stock Exchange.

The mission of the company MS&AD is “to contribute to the development of a vibrant society and help secure a sound future for the planet, by enabling safety and peace of mind through the global insurance and financial services business”. The vision of the company is “to create a world leading insurance and financial services group that consistently pursues sustainable growth and enhances corporate value.”
