The company has a fleet of 21 aircraft serving over 70 destinations in Europe, North Africa, and the Middle East. Luxair is a member of the European Regional Airlines Association and has codeshare agreements with several airlines, including Air France and Lufthansa. Luxair is committed to providing safe, reliable, and comfortable air travel for its passengers. The company offers a range of services, including in-flight entertainment, Wi-Fi, and duty-free shopping. Luxair's frequent flyer program, "LuxairClub," rewards passengers with special benefits and discounts on future flights. The company also supports a range of cultural and sporting events, as well as charitable initiatives, in order to give back to the communities it serves. As of early 2023, Luxair has a workforce of around 3,000 employees, including pilots, cabin crew, ground staff, and administrative personnel.
