TAROM (Transporturile Aeriene Române) was founded in 1954 by the Romanian government. TAROM is headquartered in Bucharest and operates from its main hub at Henri Coanda International Airport. The airline serves over 50 destinations across Europe, Africa, and the Middle East. TAROM operates a fleet of 23 aircraft, including Boeing 737s, Airbus A318s, and ATR 42s and 72s. The airline offers two classes of service on most flights: Economy Class and Business Class. In-flight amenities may vary depending on the length of the flight and the class of service. TAROM is a member of the SkyTeam global airline alliance and has codeshare agreements with several other airlines, including Air France, KLM, and Delta Air Lines. The airline also has interline agreements with other airlines, allowing for seamless connections to additional destinations. In addition to passenger flights, TAROM also operates cargo services, charter flights, and aircraft maintenance and overhaul services. The airline has won several awards over the years, including the "Best Airline in Romania" award at the Romanian Top Hotel Awards. As of early 2023, TAROM employed over 1,248 people.

The USP of TAROM is that it is the flag carrier and oldest airline of Romania. TAROM's mission is to provide safe and reliable air transportation services to its customers, while also contributing to the development of Romania's aviation industry.
