The Chlor Alkali Products and Vinyls segment produces and sells chlorine and caustic soda, hydrochloric acid, hydrogen, bleach products, and potassium hydroxide. The Epoxy segment produces and sells epoxy materials, including allylic resins, coating and adhesive resins, and other specialty epoxy resins. The Winchester segment produces and sells sporting ammunition, reloading components, small caliber military ammunition, and components for law enforcement applications. The company has a diverse customer base across various industries, including chemical, pharmaceutical, paper, aluminum, water treatment, and plastics industries, among others. Olin operates manufacturing facilities in several countries, including the United States, Canada, Brazil, Germany, and France. As of 2023, Olin Corp. employed around 7700 people.
