Stena Line is a Swedish maritime corporation and one of the world's major ferry companies. Denmark, France, Germany, the United Kingdom, Ireland, Latvia, the Netherlands, Norway, Poland, Finland, and Sweden are all served by it. The Stena Line is a main unit of Stena AB, which is a component of the Stena Sphere. Sten Allan Olsson started Stena Line in 1962 in Gothenburg, Sweden, which now acts as the company's headquarters, after purchasing Skagenlinjen between Gothenburg and Frederikshavn, Denmark. Stena Line was one of the first ferry companies in Europe to implement a computer-based reservation system for the tourism industry in 1972. The goods business industry likewise began using a computer-based reservation system in 1978. Stena AB, Stena Metall AB, and Stena Sessan AB are the three parent firms that make up the Stena Sphere. As of 2023, the Stena Sphere employs a total of 21,000 people.

Stena line's mission statement reads "We are Stena Line, one of the world's largest ferry companies with over 27,000 yearly sailings. We exist to be a trusted link between people, places, and societies. Everything we do is based on our core values passion, sustainability, and care." Its vision statement reads "Connecting Europe for a Sustainable Future."
