The company was formed in April 2020 following the merger of Raytheon Company and United Technologies Corporation. With headquarters in Waltham, Massachusetts, Raytheon Technologies operates through four business segments: Collins Aerospace, Pratt & Whitney, Raytheon Intelligence & Space, and Raytheon Missiles & Defense. The company's products and services include aircraft engines, avionics, cybersecurity, missile defense, radar, and surveillance systems. Raytheon is a technological and innovation leader which specializes in civil government, defense and cyber security solutions. It also provides state of the art electronics, sensing, C5I products and services, mission system integration, effects and mission support services. As of early 2023, it has 174,000 employees worldwide. In 2022, Raytheon Intelligence & Space, a business under Raytheon Technologies, has received the James S. Cogswell Outstanding Industrial Security Achievement Award from the U.S. Department of Defense for two of its facilities.

The USP of Raytheon Technologies lies in it being the world's largest producer of guided missiles. Raytheon mission statement states 'One global team creating trusted, innovative solutions to make the world a safer place.'
