**About the Company :** Western Digital Corporation is a leading manufacturer and provider of data storage devices and solutions. Their brand portfolio is characterized in 3 basic segments: Client Devices, Data Center Devices and Solution and Client Solutions with Client Devices being the major revenue driver. The devices are made by either using magnetic rotating disk, Hard Disk Drives (HDD), or using semiconductor technology referred to as Solid State Drives (SSD) or flash drives. The company markets its products under HGST, SanDisk and WD brands. It sells its various products through extensive network of Original Equipment Manufacturers (OEM), Cloud infrastructure providers, resellers, distributors and consumers.

The company was formed in 1970 in Santa Ana, California by Alvin B. Phillips and is now headquartered in San Jose, California. It is currently being headed by Stephen D. Milligan and has 61,800 full time employees with operations in Asia-Pacific, Europe, Middle East, Africa and United States of America. In recent times, Western Digital has also entered into joint ventures with Toshiba Memory Corporation (TMC) for development and manufacturing of innovative and low-cost NAND flash memory devices. In the past decade, Western Digital also acquired various other companies such as HGST, SanDisk, Virident Systems to name a few.

Western Digital is S&P 500 company since 2009 and enjoys a high brand equity amongst its customers which helps it acquire a top-of-mind position in ongoing increase in demand for data storage devices and solutions. Also, it boasts of one of the most valuable patent portfolios comprising approximately 14,000 patents.

The company operates in a highly competitive market and faces competition from several colossal companies in both HDD and Flash drive segment. Major competitors in HDD are Seagate Technology and Toshiba Electronic Devices and Storage Corporation. In flash drives there are numerous competitors such as Intel Corporation, Micron Technology, Samsung electronics to

name a few.

The company in 2019 saw a sharp fall in its top line with revenue falling by almost 20% as compared 2018, however, the company aims to focus on growth through investments in data center and cloud technology using innovation and value creation.
