**About the Company :** American International Group Inc. also known as AIG, is an American multinational global insurance company with operations in more than 80 countries and jurisdictions. The company provides a range of insurance products to support their clients in business and in life, primarily, general property/casualty, retirement and financial services through their General Insurance, Life and Retirement programs. AIG is headquartered in New York and it employs 46000 people internationally as of 2020. The company was founded in 1919 by Cornelius Vander Starr. AIG traces its roots back to American Asiatic Underwriters (AAU), an insurance agency established by Cornelius in Shanghai. By the late 1920's, AAU had branched out in various countries across the world. The company went public in 1968 and re-established itself as the American International Group, Inc. It was incorporated as a unifying organization between C.V. Starr's general and life insurance businesses. The company offers its services to over 90 million commercial, institutional and individual customers globally with notable firms such as Best Buy, HP and Nortek among others being some of their prime consumers. AIG's Individual Retirement business was the recipient of DALBAR Communications Seal of Excellence 2019. AIG was also awarded its Annuity Service Award for the 12th consecutive year.

American International Group's unique selling proposition or USP lies in being one of the world's largest insurance firms and one of the world's leading insurance organizations. Its mission statement reads, "Reducing fear of the future and empowering our clients through our risk expertise and financial strength."
