Telefónica is a Spanish multinational broadband and telecommunications provider with presence in 21 countries and has about 125,000 professionals. The company is listed with more than one and a half million shareholders. In 1924, the firm was founded in Madrid as Compañía Telefónica Nacional de España (CTNE), with ITT as a significant stakeholder. It operates in Europe and the Americas and offers fixed and mobile telephone, broadband, and subscription television. It also goes by the names Movistar, O2, and Vivo in addition to Telefónica. The firm is a component of the Euro Stoxx 50 stock market index. Telefónica Tech was named Best Enterprise Cloud Solution at the European IT & Software Excellence Awards, which were held in London. As of early 2023, Sacyr chooses Telefónica Tech for the management of its public cloud. Over the following three years, the technology business will oversee Sacyr's public cloud contracts with the three hyperscalers (Amazon Web Services, Google Cloud, and Microsoft Azure).

The USP of Telefonica is that it is one of the biggest telephone operators and mobile network providers in the world. The company aspires to become an Onlife Telco to realize its vision to “create, protect and boost connections in life so people can choose a world of unlimited possibilities”.
