The company is based in Farmington, Connecticut, USA, and is a world leader in products such as elevators, escalators, moving walkaways, and related equipments. Otis visualizes itself as a world-class, customer-centric, service-oriented company, aiming to connect and thrive its consumers in this taller, faster, smarter world.

As of early 2020, Otis employs more than 69,000 professionals, including 40,000 field professionals, working in over 1400 branches & offices across the globe, moving around 2 billion people daily.
