The Nippon Telegraph and Telephone Corporation commonly known as NTT, is a Japanese telecommunications company headquartered in Tokyo, Japan. Nippon Telegraph and Telephone Public Corporation, also known as Den-Den Ksha, was created as a state monopoly in August 1952 to take over the Japanese telecommunications network run by AT&T during the Occupation of Japan. Den-Den Ksha was privatised in 1985 to promote competition in the nation's telecom market. It is ranked 50th in Fortune Global 500 and has 332,000 employees as of early 2023. For demonstrating the initiatives for service improvement, revenue growth, cultural change, and transformation, NTT Com was awarded Operator of the Year for the seventh time in 2020. Additionally, NTT Communications received recognition from Frost & Sullivan's 2020 Asia Pacific Best Practices Awards Program in two categories.

The USP of NTT is that it ranks third among Japanese publicly traded companies and is the fourth-largest telecommunications company in the world based on revenue. NTT's mission statement reads, "NTT DATA Group uses information technology to create new paradigms and

value, that help contribute to a more affluent and harmonious society".
