About the Company: Headquartered in Pittsburgh, Pennsylvania, Wabtec Corporation is one of the world's foremost rail technology companies, which provides freight rail, transit, mining, industrial or marine solutions. It is a leading supplier of equipment, digital solutions, systems and other value-added services. Wabtec originated after the merger of Westinghouse Air Brake Company and MotivePower in 1999. With a legacy of more than 150 years, it aims to develop a sustainable network of freight and passenger transport, and highly values safety, innovation, operational excellence and teamwork. Wabtec is the world's biggest publicly traded company under rail equipment segment. Wabtec has strong digital expertise, technological innovation and world-class manufacturing setups due to the collective expertise of Wabtec, GE Transportation and Faiveley Transport. It works mainly in two segments: 1. Freight (65% of total business): It consists of Equipment, components, digital electronics and other services like logistics support. 2. Transit (35% of total business): It consists of Aftermarket services and equipment. It has presence in over 50 countries, having Corporate HQ in Pittsburgh, Global Transit HQ in Paris and Global Freight HQ in Chicago with about 27K employees worldwide as early 2021. It is one of the Fortune 500 companies, with an annual revenue of 8 billion USD. Approximately 45% of the revenue is generated from US and rest 55% is generated from its other markets. 55% of Wabtec's business is from the aftermarket services and 45% is generated through OEMs. The company's core values are "At Wabtec, we make things – great things – and always have.
