Cobham Limited is a British aerospace production company which is headquartered in Wimborne Minster, England. In 1934, Cobham was founded by Sir Alan Cobham as Flight Refuelling Limited (FRL). The Company's aerial refuelling appliances broke new ground, comprising of a round-the-world flight by specially-equipped Boeing B-50 Superfortresses in 1948. Ever since this breakthrough, a wide range of aircrafts have since been equipped with Cobham's refuelling equipment. It is organised into three divisions: 1. The Cobham Mission Systems division is the market leader in ariel refuelling worldwide. 2. The Cobham Advanced Electronic Solutions division concentrates in radar, communication and electronic warfare systems. 3. The Cobham Aviation Services division supplies a range of aviation services including Flight training to military and civilian consumers and Search & Rescue operations. It operated Defence Helicopter Flying School, training helicopter pilots for British armed forces. Cobham produces the Guardian ST820, a battery-operated tracing device used by the FBI, an American intelligence agency. The company has received the Queen's Award for Enterprise in the International Trade category for its capability to provide leading edge intercom systems to customers around the globe. In 2020, Cobham plc was acquired by Advent International. In March 2022, Cobham Special Mission and Acacia Systems, a top South Australian provider of defence software and systems engineering, collaborated on a Dash-8 fleet modification project.

Cobham's Unique Selling Proposition or USP lies in it being the world leader in advanced tactical military vehicle intercom systems. Cobham's mission statement reads, "As the world's leading supplier of critical control solutions, we help our customers to increase the safety and mission capabilities of their personnel and equipment in extreme environments".
