About the Company : Motorola Solutions, Inc., is an American company which provides data communications and telecommunication equipment, an offspring of the Motorola Company, following the spinoff of the mobile phone division into Motorola Mobility in 2011. It has its headquarters in Chicago, Illinois. The company is the legal successor of the old Motorola, Inc. Which was founded in 1928; In January, 2011 Motorola Solutions started trading as a separate independent company. It manufactures and sells communications products and services to public safety and government agencies (law enforcement, fire, emergency medical services, and national government security) and also private entities which involves utilities, mining, energy, hospitality, retail, manufacturing, transportation and logistics. The company also produces two-way radios and public radio systems for first-responders, law enforcement and software packages for command centers, mapping and drone surveillance. Motorola Solutions also manufactures body cameras under the Watchguard Video brand, emergency sirens under the Futurecom Systems brand and security surveillance under the Avigilon brand. In September 2020, the company completed its acquisition of Polaris Networks a global Solutions provider for wireless technologies. On 11 February, 2021 Motorola Solutions announced a new Video-as-a-Service offering, which combines body-worn cameras, digital evidence management software and cloud-based support in a bundle for law enforcement agencies.
