In 1962, the company was founded by brothers Tsai Wan-lin and Tsai Wan-chun, as a life insurance company. Cathay merged its various units and incorporated itself as a financial holding company. The operation of the company takes place through the following segments: Banking, Life Insurance, Securities, Properties and Casualty Insurance, and others. The Banking operating segments handles the authorised businesses of commercial banks provided by the Banking Act of the Republic of China. The Life Insurance segment's focal point is on the sales of traditional insurance policies, floating-rate annuity insurance products and investment-linked insurance policies. The Properties and Casualty Insurance segment consist of fire, marine, land and air, bonding, reinsurance, liability other insurance. The Securities segment comprises of securities brokerage, discretionary, and underwriting. The Other segments involve assets, liabilities, revenue, and expenditure. As of early 2022, Cathay Financial employees over 42,000 people.

Cathay Financial Holdings' Unique Selling Proposition or USP lies in it being the No. 1 life insurer in terms of total assets and total premium, largest brokerage settlement bank in Taiwan.
