Quanta has enlarged its businesses into home entertainment, enterprise network system, automotive electronics, mobile communication and digital home markets. It also outlines, manufactures and market GPS, comprising in-car GPS, Bluetooth GPS. The subsidiaries of Quanta Computer Incorporated includes: Quanta Cloud Technology, Face Vision Technology, Cloudcast Technology and TWDT Precision Co. Ltd. Quanta Cloud Technology is a provider of data centre hardware. Face Vision Technology includes telecommunication, webcam, and electronic products. Cloudcast Technology Inc. involves information software and data processing. In 2021, the firm plans to integrate big data management to develop a complete ecosystem for Artificial Intelligence (AI) tools.
