About the Company: RWE AG is a German multinational company which generates and trades electricity in Asia-Pacific, Europe and the United States. It is headquartered in Essen, Germany. In 1898, the company was founded in Essen as Rheinisch-Westfälisches Elektrizitätswerk Aktiengesellschaft by EAG & Company and others and in 1990 it was renamed as RWE AG. It started its first operating station in 1900. The company was reorganized to hold energy, mining and raw materials; petroleum and chemicals; waste management; mechanical and plant engineering; and construction divisions in 1988. RWE is organized around four core areas: Offshore Wind, Onshore Wind/Solar, Hydro/Biomass/Gas, Supply & Trading. In addition to these, there is also a Coal/Nuclear segment. RWE completed its asset swap deal with E. ON in July 2020 and also transferred the international renewable generation portfolio of E.ON and innogy to RWE. The company aims to complete the construction of western part of Big Raymond (240 MW) which was delayed due to Covid-19, by the beginning of 2021. RWE AG received gold at the

RWE AG's Unique Selling Proposition or USP lies in being the world's second largest in offshore wind power, and Europe's third largest in renewable energy. RWE AG's mission statement reads, "As a leading electricity producer, we take the initiative in providing clean electricity generation." We have thus defined the purpose of the new RWE as: "Our energy for a sustainable life". We will put all our energy into making a sustainable life possible".
