About the Company : Palantir Technologies Inc. is a public American company that provides software platforms for various institutions. It was founded in 2003 and headquartered at Denver, Colorado. It specializes in big data analytics which are integrated, managed and securely saved on large scales. The collected data is layered with applications for human driven analysis. The company was founded by Peter Thiel, Nathan Gettings, Joe Lonsdale, Stephen Cohen, and Alex Karp. The company initially had a difficult time finding investors, but gradually over time the company was known for its distinguished belief in artificial augmentation of data. This helped the company become noteworthy. The company today operates in two segments namely – governmental and commercial. It deals with clients like the CIA, US federal government, US allied governments abroad etc. as well as private companies like Airbus, Ferrari, etc.

The company aided the NHS (National Health Service, UK) with its COVID-19 efforts in 2020. Other countries have also used Palantir's software to track the virus and found ways to contain it as well. The company has three basic products known as Palantir Gotham, Palantir Foundry and the most recent addition Palantir Apollo. Palantir Technologies' software platforms are used across 40 industries located in more than 150 countries. The company has 2,439 full-time employees as of early 2021.

Palantir Technologies' USP or unique selling proposition is its pioneering technology in the field of software development. Its interface permits people with varied technical skills to make optimum use of its software to collate and integrate its data in an organized manner. Timely access, safe storage and continual services across time zones catapulted the company to the market's top preference.
