About the Company : The Smurfit Kappa Group plc, Europe's leading corrugated packaging company is headquartered in Dublin, Ireland. Along with being one of the leading paper-based packaging companies in the world, it is also listed on the London Stock Exchange. In 1934 it was established as a box-maker in Rathmines, Dublin. In 1938, it was acquired by Mr Jefferson Smurfit and in 1964, it was listed on the Irish Stock Exchange. It acquired a partial interest in Time Industries, which is a Chicago-based paper and packaging company, in the year 1974. The company thus grew under the leadership of the son of its founder, Sir Michael Smurfit, who became the Chief Executive of the company in 1977. In 1998, the company merged its 46%-owned US business, to form Smurfit-Stone Container Corporation with Chicago-based Stone Container Corporation. The main products and services of the company include specialization in manufacturing paper-based packaging, with a network of paper, recycling and forestry operations. It is also an integrated producer, with packaging plants sourcing the major part of their raw material requirements from its own paper mills. The company employs around 46,000 employees across 35 countries. The regional headquarters of the company are in Amsterdam and Miami. Smurfit Kappa has been awarded with the 18 EFIA Awards in 2020, and was recognised for its innovative packaging. The company's bright idea for packaging led to the achievement of the ScanStar Awards in 2019. It also won the top Latin America CSR Award for company transformation in the same year.

Smurfit Kappa's Unique Selling Proposition or USP lies in it being a FTSE 100 company along with being one of the leading providers of paper-based packaging in the world, having operations in over 30 countries. Smurfit Kappa's vision statement reads "Our vision is to be a globally admired business, dynamically delivering secure and superior returns for all stakeholders. How we do this, goes beyond dynamic business performance. We strongly believe in our responsibility to

our people, our environment and the countries in which we operate.”
