About the Company: Northrop Grumman is an American global aerospace and defence technology company. It is headquartered in West Falls Church, Virginia, United States. As of 2021, the company leverages the talent of 97, 000 employees. The company was formed in 1994 when Northrop Aircraft bought Grumman Aerospace which built the Apollo Lunar Module to create Northrop Grumman (NG). The company operates through four main sectors: 1. Aeronautics Systems headquartered in Redondo Beach, California, manufactures aircraft, spacecraft, high-energy laser systems and microelectronics for the U.S. and other nations. 2. The Defense Systems sector headquartered in McNair, Virginia works on "the entire life cycle of civil and defence platforms and capabilities through a range of services. 3. Mission Systems headquartered in Linthicum, Maryland produces military radar, sensors, and related products, also involving C4I radar systems for air defence, Airspace Management radar systems such as AMASS, and battlefield surveillance systems like the Airborne Reconnaissance Low (ARL). 4. Space Systems which is also known as Northrop Grumman Innovation Systems which now includes the construction and launch of the Cygnus spacecraft. In 2021, Northrop Grumman Corporation is set to launch the company's 15th resupply mission (NG-15) to the International Space Station under NASA's Commercial Resupply Service-2 contract and the development and production of James Webb Space Telescope an orbiting observatory, is also under construction and its launch is expected in 2021.

Northrop Grumman's Unique Selling Proposition or USP lies in it being one of the world's largest weapons manufacturers and military technology providers and it ranks No. 96 on the 2020 Fortune 500 list of America's largest corporation. Northrop Grumman's mission statement reads, "Our mission is to be at the forefront of technology and innovation, delivering superior capability in tandem with maximized cost efficiencies. The security solutions we provide help secure freedoms for our nation as well as those of our allies".
