About the Company : Evraz plc is a British multinational vertically mining and steel making company. It is headquartered in London, United Kingdom. It has its operations mostly in Russia, but has its offices in Ukraine, Kazakhstan, Czech Republic, Italy and United States. In 1992, the company was formed as a small metal-trading business. The company is holding high self sufficiency in iron ore and excess coking coal production. It also controls logistics assets and engages in some metal trading. EVRAZ Steel segment utilizes locally sourced raw materials to produce steel products and sells it for construction projects and domestic infrastructure while considering the approach of exports. The company's vanadium business deals with processing vanadium slag from steel making operations. It's coal segment supplies raw materials for EVRAZ's steel mills, supplies coking coal to crucial domestic coke and steel producers, exports its products to overseas customers. Evraz Group's North America Steel segment's focal point is on premium markets in the Western US and Canada, contributing high value-added products comprising infrastructure steel, rails, large diameter pipes and oil country tabular goods. In fiscal 2020, the company aims at introducing new profiles in structural product range, maximize its internal coal supplies and increase its shipments through ports in Asia. EVRAZ Group has been awarded the 'Best Annual Report' award among foreign companies.

EVRAZ Group's Unique Selling Proposition or USP lies in it being one of the largest participants in the domestic coking coal market through its affiliates. The company believes that business sustainability is associated with the prosperity of the regions where it operates and the satisfaction of local communities which it supports through social and improvement programmes.
