About the Company : The Blackstone Group Inc. is an American alternative investment company. It is headquartered in New York, United States. In 1985, Blackstone was founded as a merger and acquisition firm by Peter G. Peterson and Stephen A. Schwarzman. Blackstone became a public company with a \$4 billion IPO, becoming one of the first major private equity firms to list shares in its management company on the public stock market in 2007. The company has offices in the United States, as well as offices in Dublin, Düsseldorf, London, Luxembourg, Paris, Sydney, Tokyo, Hong Kong, Singapore, Beijing, Shanghai, Mumbai, and Dubai. Blackstone operates through four primary departments: private equity; real estate; hedge funds; and credit. Blackstone's private equity business has been one of the largest investors in leveraged buyouts in the last decade, while its real estate business has actively obtained commercial real estate. In June 2023, Blackstone completed its acquisition of Cvent a leading provider of technology for meetings, events, and hospitality for \$4.6 billion. Blackstone closed an income-generating asset deal with Prestige Group for \$1.5 Billion for the construction of office projects and retail malls including two hotels in 2021.

The Blackstone Group Inc.'s Unique Selling Proposition or USP lies in it being the world's largest private equity firm by capital commitments as ranked by Private Equity International. The Blackstone Group Inc.'s mission statement reads, "Our mission is to deliver enhanced returns and capital preservation over the long term. All our businesses reflect Blackstone's strong partnership culture, personalized approach, commitment to exceptional performance, and uncompromising integrity".
