About the Company : Virgin Galactic is a spaceflight firm based in Las Cruces, United States that is part of the Virgin Group. It develops commercial spacecraft to provide space travellers with suborbital spaceflights. Virgin Galactic's suborbital aircraft is launched from beneath White Knight Two, a carrier plane. Sir Richard Branson, a British entrepreneur who previously formed the Virgin Group and the Virgin Atlantic airline, established the Virgin Galactic in 2004. The top management team at Virgin Galactic is on the road to frequent commercial spaceflight, developing next-generation vehicles and investigating new possibilities. Virgin Galactic's outreach programme, Galactic Unite, aims to inspire good change in young people by channelling its collective energy and resources, ensuring that future generations are prepared to apply a space perspective to Earth's most pressing problems. On June 3, 2021, Virgin Galactic announced a new contract to carry Kellie Gerardi, an IIAS researcher, on a specialised research flight, during which Kellie will perform experiments and test innovative healthcare technology while in space. The company is planning to commence its commercial service in Q4 2022.

Virgin Galactic's Unique Selling Point or USP lies in it being the world's first commercial spaceline and a vertically integrated aerospace firm. Virgin Galactic's mission statement reads, "To be the spaceline for Earth – means we focus on using space for a good while delivering an unparalleled customer experience".
