**About the Company :** Bechtel Corporation is a 120 year old American engineering, procurement, construction and project management company, headquartered in Reston, Virginia. In 1898, Warren A. Bechtel founded this company in San Francisco, California as a construction company. Although Bechtel initially faced a few hurdles, it is now considered as the largest construction company in the United States. It offers services like infrastructure, defense and nuclear security, energy, environmental cleanup and management, mining and metals, petrochemicals and water to private as well as government organizations. In the span of 120 years, Bechtel has completed more than 25,000 projects in 160 countries across the world. As of June 2021, the company has 17,897 employees. Some of the Bechtel's major projects include Albanian Motorway in Albania, Ankara-Gerede Highway in Turkey and Third Generation Project in Kazakhstan. In May 2021, it announced that World Energy has selected its SWSPlus technology to treat waste water at its facility in California.

Bechtel Corporation's unique selling proposition or USP lies in being the largest construction company in the United States. Bechtel Corporation's vision statement reads, "Be the world's premier engineering, construction, and project management organization by achieving extraordinary results for our customers, building satisfying careers for our people, and earning a fair return on the value we deliver."
